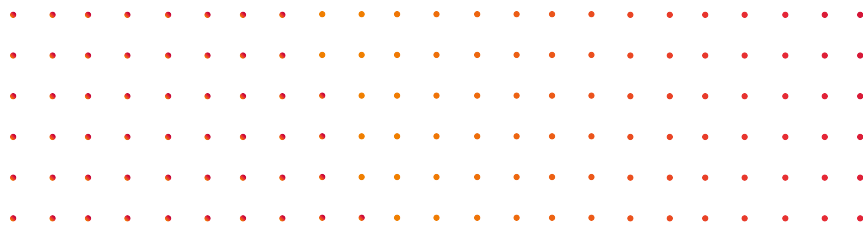

About FEVE

FEVE is the European Federation of glass packaging makers and is the official voice of the glass container industry at European level. Our members produce glass bottles, jars and flacons for the food, beverage, cosmetics, perfumery, and pharmaceutical sectors.

FEVE has 60 corporate members belonging to over 20 independent corporate groups. Their 160+ manufacturing plants are located across 23 European States and maintain an estimated 125,000 direct and indirect jobs along the total supply chain. Its members produce over 80 billion glass containers per year.

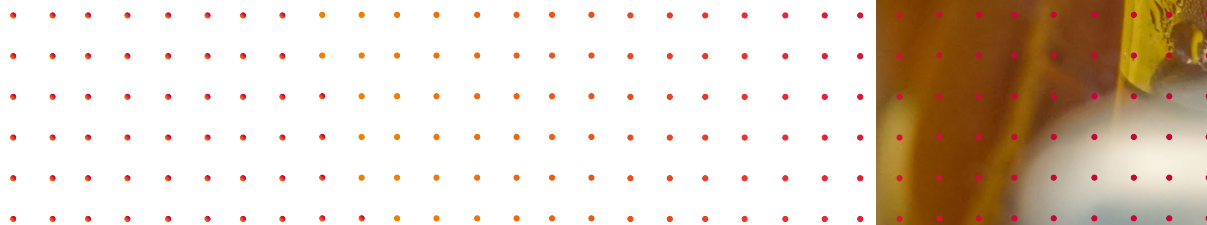


About Glass Packaging

Glass is a non-reactive material, which means that anything that comes into contact with it will not be affected or damaged. When it comes to food preservation, this is crucial. As a glass jar or container is impermeable, no gas can get in or out, so your food remains perfectly edible and healthy. In the modern era, glass packaging is not only recognised by consumers as one of the most recyclable and environmentally friendly packaging materials but actually achieves some of the highest recycled and reuse rates in Europe.

Today glass packaging for food preservation has found its way into the homes of millions as something people use and love every day. It's also the primary packaging used for exports of Europe's prestigious wines, spirits, perfumery, cosmetics and pharmaceutical products accounting for €250 billion contribution to EU trade each year.

But the history of glass begins in 4000 BC, when archaeologists found the first evidence of human-made glass. Since then the glass industry has undergone several revolutions. Today it is on a visionary path to ensure that glass containers remain fit for a fully circular and climate neutral world.





FEVE is recruiting a new Secretary General to lead the association of glass container producers in its revolutionary transition to low carbon glass packaging. The Secretary General is appointed by the Board of Directors to oversee the execution and implementation of the decisions of the General Assembly and the Board and to manage the daily operations of the Association.

The candidate should have 15 years professional experience in managing people in the Brussels Bubble policy related context. Having similar positions or a background in politics, public affairs and industry representation at EU level and being familiar with the EU decision making, political and regulatory processes. Preferably with a knowledge of the food and beverage industry value chain. And have a good business understanding and capable of bringing a novel and strategic approach.
